

**Memorandum of Cooperation**  
**between the Institute of Oriental Studies of the National Academy of Sciences of Armenia and**  
**the Institute of History of the University of Rzeszów**

The present Memorandum is an agreement of cooperation between the Institute of Oriental Studies of the National Academy of Sciences of Armenia and the Institute of History of the University of Rzeszów (Poland).

The Memorandum does not impose the legal obligations on the parties; it only expresses/ sets out the will of the parties to establish cooperation and promote the mutual productive partnership between them.

The Institute of Oriental Studies of the National Academy of Sciences of Armenia and the Institute of History of the University of Rzeszów (Poland), hereinafter referred as "Parties", taking into consideration the close ties between two countries in cultural and scientific cooperation, as well as in historical studies, common interests and results, based on professional cooperation, agree on following:

**Article 1**

To develop multiply cooperation, including professional experience and information exchange in the field of history and oriental studies.

**Article 2**

To develop scientific cooperation, including the organisation and participation in scholarly meetings, conferences and seminars.

**Article 3**

To search materials and documents, exchange the information; within the framework of civil law agreements, early printed books, historical documents and archival materials which are valuable for oriental, Caucasian, Armenian and Polish studies, aiming to enrich the proper scientific founds and collections. If one party decides to share the information with other (the third) party, it should inform the other part about this decision in the written form.

**Article 4**

Based on civil law agreements, to collaborate in the fields of scientific-educational programs and participation in grant educational projects. To exchange of teaching staff and administrative staff, in the volume of reading lessons and specialized courses, conducting seminars, colloquiums, etc.

### Article 5

Based on additional agreements, the Parties agree jointly publish the collections of documents, exchange scholars and experts, aim to the historical, cultural researches, including those in oriental studies and share their experience in history, philology, oriental, Armenian and Polish studies.

### Article 6

The present Memorandum can be broadened or limited based on mutual agreement.

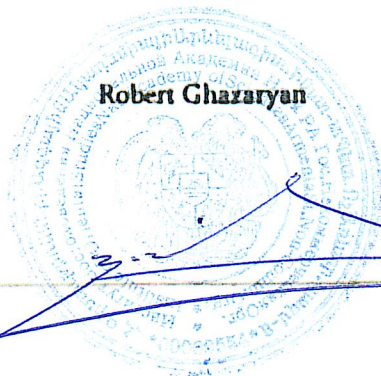
### Article 7

The present Memorandum shall take effect from the date of its signature and remain valid for five (5) years. The effect of the Memorandum will be automatically renewed for the following period unless one of the parties notifies the other of termination or alteration at least three (3) months in advance of the date.

The Memorandum is signed in 5th on November 2021 in two copies (two copies in English). Each of the copies has an equal juridical value. In case of misunderstanding in reading of the text, the English version will have priority.
